We act on behalf of Jill Cathrine Gumble and John James Gumble the registered owners of the above property, as registered under title numbers HD498288 and HD492759. The land held, is that formally known as The Green Man Public House, and in respect of which a registration in the ACV Register took place on 11 October 2018 under reference CAN 05/18.

Our clients are intending to dispose of The Green Man, being the property comprised in the above named titles and the purpose of this letter is to provide notification of such pursuant to the provisions of the Localism Act 2011.

We understand that as from your receipt of this letter an initial moratorium period of six weeks will commence during which you will update the register to show our clients intention to dispose of the property, and you will contact Widford Parish Council the nominating party.

In the meantime, we would be grateful if you could please check your records as to whether notice of an intention to sell was not provided by our clients in or above November 2018. We raise this as our clients have copied us in on correspondence exchanged between our clients and Jill Buck on behalf of Widford Parish Council dated 14 and 15 November 2018 from which it is clear that notice of an intention to sell had been given at least to the Parish Council, but our clients have not been able to provide us with evidence that notice was given to yourselves, which we believe to be the requirement under the Act.


